

GLOBAL, MPA

The University of Pennsylvania's Global Master of Public Administration (G-MPA) is an innovative graduate degree designed especially for academically select and highly qualified present and future leaders in government, nonprofit, and business organizations who wish to hone their problem-solving skills and go on to make a real difference in improving human well-being locally, nationally, and globally. This online program has been crafted by a faculty of multi-disciplinary and multi-lingual scholars in consultation with present and former leaders in government, business, and the nonprofit sectors. The Penn G-MPA enables students who are proficient in English and at least one other language to earn their graduate professional degree in as little as one year (full-time study) or within three years (part-time study). Students complete weekly course assignments at whatever times work best for them. The multi-disciplinary G-MPA provides a skills-based, career-enhancing curriculum that focuses on comparative public administration, global leadership and public-private problem-solving. Individually tailored educational experiences further enhance graduates' ability to confront today's global challenges and work collaboratively across borders and sectors—in government, public service, NGOs, commerce and more. The program provides case-based learning addressing international, national and local level governance and leadership, problems and solutions.

Curriculum

The Global Master of Public Administration is an interdisciplinary online graduate program with a focus on comparative public administration, global leadership and public-private problem-solving. Students take ten all-online, asynchronous courses; receive weekly synchronous online course advising and faculty mentoring; participate at their discretion in special synchronous sessions featuring global leaders in business, government, and the nonprofit sector; and, at their option, come to Penn the week before graduation to meet the GMPA faculty and staff in person and participate in special sessions featuring leading experts on global affairs. In order to complete the degree, students must complete 10 course units (CU).
